

CONSENT TO ELECTRONIC COMMUNICATIONS

By signing this Consent to Electronic Communications (the "Agreement") below, the named organization below ("you" or "your") consents to receive documents from United Methodist Foundation ("we," "us," or "our") in electronic paperless form, rather than delivery by U.S. mail, to the valid, current email listed below. The documents you may receive electronically will include, but are not limited to:

- Offering Circulars;
- Any disclosures or waivers that we are required to give you from time to time under applicable federal or state laws; and
- General correspondence.

In this Agreement, this information is called "Electronic Communications."

Computer Requirements

To receive and retain Electronic Communications, you will need:

- A valid email application, whether an independent software program or accessed through the internet.
- Adobe Acrobat Reader, which you can download for free from http://www.adobe.com/products\acrobat or http://get.adobe.com/reader/.
- A personal computer, operating system, and internet access provided at your own expense.
- Sufficient electronic storage capacity on your hard drive or other storage medium, or a printer that is capable of printing from your internet browser.

How Electronic Communications Will Be Made

Electronic Communications will be contained in, or attached to, an e-mail message sent to the e-mail address you provide to us. We recommend you add @umfmichigan.org to your email service as a trusted sender to ensure receipt of Electronic Communications.

Changing Your E-Mail Address or Withdrawing Your Consent

You agree to provide us with a current e-mail address to which we may send Electronic Communications and promptly notify us of any changes to your electronic address. You may withdraw your consent to receive Electronic Communications at any time. Undeliverable Electronic Communications

If an Electronic Communication is returned to us undeliverable, we will send you a paper copy within five (5) business days via the U.S. Postal Service to the mailing address shown in our records. We will stop sending you Electronic Communications if Electronic Communications to you are returned to us undeliverable three (3) consecutive times. If that happens, we will send all future Electronic Communications to you via the U.S. Postal Service at the mailing address shown in our records.

Paper Copies of Communications
