## CONSENT TO ELECTRONIC COMMUNICATIONS

By signing this Consent to Electronic Communications (the "Agreement") below, the named organization below ("you" or "your") consents to receive documents from United Methodist Foundation and the Michigan Area Loan Fund ("we," "us," or "our") in electronic paperless form, rather than delivery by U.S. mail, to the valid, current email listed below. The documents you may receive electronically will include, but are not limited to:

- Offering Circulars for the UMF Collective Investment Funds of Michigan, LLC and the Prospectus for Michigan Area Loan Fund.
- Any disclosures or waivers that we are required to give you from time to time under applicable federal or state laws; and
- General correspondence.

# **Computer Requirements**
