- 4. A copy of a <u>Warranty or Quit Claim Deed</u> which includes the legal description of the property, the legal name of your church, and the <u>Trust Clause</u> as required by the <u>Book of Discipline</u> of the United Methodist Church.

### IF CONSTRUCTION IS INVOLVED:

- 5. One copy of the Architect's contract
- 6. One copy of the **Building contact**
- 7. A Performance Bond Labor and Material Bond.
- 8. <u>Builder's Risk and Fire Insurance Policy with extended coverage</u> endorsement equal to the cost or replacement cost whichever is greater. The Mortgage clause must name as mortgagor the Missions and Church Extension Trust Fund.
- 9. Two copies of **Mortgage Survey** by an engineer, as a basis for title processing.
- 10. A Mortgage Title Insurance Policy this will be secured by the First American Title Company.
- 11. If this loan is approved, you will be **invoiced for one half of one percent of the loan amount as a loan commitment fee.** Upon payment of the fee, these requirements, where applicable, will be repeated in a letter committing funds to your project.
